It is with gratitude and a great sense of responsibility that I sit down to compose my first message as the Society's president. For many years, the FCHS has been a warm intellectual home to me, as it has to so many of us. I gave my very first conference paper at the 2000 meeting in Charleston, and subsequent conferences have brought treasured conversations, mentors, and friends. It is a pleasure to have this chance to give back to the Society and to help carry on its tradition of welcoming and nurturing young historians.

My first happy task is to thank Nathalie Dessens on behalf of all of us for her work as President over the last two years. Jennifer Boittin, the outgoing treasurer, deserves hearty thanks, as well. Neither seems to want to take her well-earned break from service to the Society, however, as both have agreed to serve on the program committee for next year's conference in Aix! I am also delighted to welcome Rick Fogarty and Spencer Segala, who join me as the new vice-president and treasurer, respectively, in trying to fill the very big shoes Nath and Jennifer leave behind. We are fortunate that the website, newsletter, and journal remain in the capable, experienced hands of Katie Edwards, Judith DeGroat, and Micheline Lessard and Ken Orosz.

Together, outgoing and continuing members of the board have done an enormous amount over the last year to make the Society run more smoothly. Although much of this work went on "under the hood," updates to the website and a new online submission system for the journal in particular should make it easier to renew memberships, register for the conference, and submit manuscripts to *French Colonial History*. The 2015 issue of *FCH* should be out soon, with the 2016 issue not far behind. Micheline and Ken are now welcoming submissions for the 2017 and 2018 issues. Please consider submitting a manuscript and let your colleagues and doctoral students know about the journal, too.

A second round of thanks goes to Micheline Lessard for hosting a wonderful conference in Ottawa in May, in addition to carrying on her editorial duties, as well as to the other members of the local arrangements committee (Nicole St Onge, Ryme Seferdjeli, and Guy Dondo) and program committee (Robin Mitchell, Sarah Zimmerman, and Benoît Grenier). Although I was unable to attend myself, all reports were that it was a great success. Chair Jean-François Brière announced the winners of the 2016 book prizes on behalf of the Book Prize Committee. Congratulations to Julia Gaffield, who was awarded the Mary Alice and Philip Boucher Prize, for her book, *Haitian Connections in the Atlantic World. Recognition after Revolution* (University of North Carolina Press, 2015), and Emily Burrill, who was awarded the Alf Andrew Heggoy Prize for *States of Marriage: Gender, Justice, and Rights in Colonial Mali* published by Ohio University Press (2015). No Eccles Prize was awarded this year, because there was no article by a graduate student in the 2015 issue of the journal.

The 2017 conference, to be held in Aix-en-Provence, promises more conviviality and stimulating discussion, along with a chance to combine conference-going with some research at the Archives nationales d'Outre-Mer. Isabelle Dion and Pierre Gombert of the ANOM are hard at work on local arrangements, and the program committee stands ready to get started reading proposals. The full call for papers appears below, and I urge those organizing panels to consider diversity and inclusion as they do so. Venez nombreux!

In addition to H-French-Colonial and other H-Net listservs, those looking for potential co-panelists or just to keep up with news related to the Society or to French colonial history are invited to join the FCHS Facebook group that was started last year.

Thanks to the efforts of former FCHS President Sue Peabody and the support of the ANOM, the 2017 conference will also an exciting new opportunity for graduate students to participate in a series of special professional development workshops focused on archives, grantwriting, and publishing. Full details are below and on the website, but we hope that graduate advisors, especially to students from underrepresented groups, including minorities and first-generation university students, will encourage them to sign up. Sue Peabody is happy to answer any questions (speabody@wsu.edu) about the workshops.

Looking further ahead to future conferences, we will have the cultural and culinary pleasure of gathering in 2018 in Seattle, Washington, where the indefatigable Sue Peabody and Sarah Zimmerman will be the local organizers. In 2019, the conference will return to Canada, where Benoît Grenier and Patrick Dramé will host us at the Université de Sherbrooke, Québec. The board is now accepting proposals for 2020 and beyond. If you are interested in hosting the conference, instructions for preparing a site proposal can be found on the FCHS website. Please let me know if you have any questions about hosting or about the proposal process.

At the same time that we celebrate the vitality of our scholarly community, events of the last year, including the terrorist attacks in France and Belgium, the civil war and refugee crisis in Syria, the Black Lives Matter movement in the U.S., and the mobilization of Native people in the Idle No More movement and, closer to my home in Iowa, the Standing Rock Sioux Coalition in defense of tribal rights in North America, are a sobering reminder of the important work FCHS members do to understand colonial and postcolonial projects that resonate in contemporary violence and injustice. These events and others make me I ever more mindful of the human costs and consequences of the histories we study, as well as of the colleagues around the world who bear those costs and consequences most directly.

Let us hope that the coming year will bring fewer occasions for colonial historians to offer perspective on tragic events and more opportunities to enjoy warm collegiality, even as we remember the responsibilities that come with our work as colonial historians.

Mary Alice and Philip Boucher Book Prize, 2017

The Boucher book prize is awarded annually by the French Colonial Historical Society in honor of long time members and active supporters Mary Alice and Philip Boucher. The prize recognizes the best book published in the preceding year dealing with the French colonial experience from the 16th century to 1815. Books from any academic discipline will be considered, providing that they approach the French colonial experience from an historical perspective. The deadline for this year's submissions is March 1, 2017. Questions about the submission process should be addressed to Dr. Jean-François Brière, Chair of the FCHS Book Prize Committee, at jfbriere@albany.edu

Applicants or their publishers should submit three copies of books published in 2016 (date of publication is determined by the copyright page of the book), one to each of the book prize committee members. Please indicate clearly that the submission is for the Boucher Prize.

Alf Andrew Heggoy Book Prize, 2017

Each year the French Colonial Historical Society presents a book in honor of one of its founding members, Alf Andrew Heggoy. Book prize recognition includes an award of US \$400 for the best book published during the previous year dealing with the French colonial experience from 1815 to the present. Books from any academic discipline will be considered but they must approach the consideration of the French colonial experience from an historical perspective. The deadline for this year is March 1, 2017. Questions about how to submit entries should be addressed to Dr. Jean-François Brière, Prize Committee Chair at jfbriere@albany.edu

Applicants or their publishers should submit three copies of books published in 2016 (date of publication is determined by the copyright page of the book), one to each of the book prize committee members. Please indicate clearly that the submission is for the Heggoy prize.

2015-2016 Book Prize Winners

Mary Alice and Philip Boucher Prize

Winner: Julia Gaffield, *Haitian Connections in the Atlantic World. Recognition after Revolution* (Chapel Hill: University of North Carolina Press, 2015).

Haitian Connections in the Atlantic World is a ground-breaking work that deals with the relations between Haiti and the outside world during the years immediately following the Haitian declaration of independence in 1804. This was a crucial period for the young nation as no country recognized its emancipation. While Napoleon was busy conquering Europe, French authorities made desperate attempts to block Haiti's relations with the outside world. Scholars have generally acknowledged that Haiti was treated as a threat to the security of slaveholding societies and isolated by European powers and the United States. Julia Gaffield has written a book which persuasively challenges that assertion. She explored sources from American, Danish, Dutch, British and Spanish archives, and discovered that far from being sealed off in isolation, Haiti was able to maintain active commercial connections with a number of countries, including British colonies and the United States. At the same time, this most unusual situation raised a web of diplomatic, economic and legal questions that the author explores in great detail: issues related to the definition of sovereignty and legal rights that questioned Haiti's status: was it still a French colony or an independent state? We see how the different conceptualizations of Haiti's place in the Atlantic world shaped post-independence experiences and made for a diversity of foreign interactions with the new country. The author's approach offers a significant model for thinking about international relations in less formal terms, showing how Haiti functioned de facto as a sovereign state in her relations with Britain, the United States and other nations long before formal diplomatic recognition. The committee felt that it was important to recognize this splendid book for the bright light it sheds on a unique moment in the history of the emancipation of Saint-Domingue.

Alf Andrew Heggoy Book Prize

Winner: Emily Burrill, *States of Marriage: Gender, Justice, and Rights in Colonial Mali* (Athens: Ohio University Press, 2015).

Based on a close scrutiny of court files in local archives as well as on oral testimony, *States of Marriage: Gender, Justice, and Rights in Colonial Mali* examines the institution of marriage in French Sudan from pre-colonial times to the end of the colonial period. The author provides a history of the ideological debates surrounding the meaning of marriage and the influence of the French presence in the region on the practice and legal norms relating to marriage. She argues persuasively that conflicts over power, access to property, religious authority, and ideologies of gender all centered on debates over marriage. She raises important questions that are relevant not only to gender studies but also to the nature of French colonial rule and the social and cultural aspects of its policies. Although her book focuses on marriage, it also sheds light on other important aspects of French colonial rule, such as the concept of justice in the colonial context, the relentless attempts to codify African practices and legal norms, and the patriarchal and repressive nature of the colonial regime in spite of its pretense of defending African women's rights. *States of Marriage* is not only a superb, well-researched scholarly achievement; it is also wonderfully written and reads like a good fiction book. For all these reasons, the committee felt that it was appropriate to select this book as winner of this year's Heggoy Prize.

W. J. Eccles Prize, 2017

The W.J. Eccles Prize is to be awarded annually to the graduate student or recent post-graduate student judged to have presented the best paper at the annual meeting of the French Colonial Historical Society and subsequently published in the society's journal *French Colonial History*. The prize is meant to encourage beginning academics in the field of French Colonial History and to honor the career of one of French Colonial History's greatest historians. Bill Eccles was an outstanding supporter of graduate students and this prize is meant to continue his work by encouraging those at the beginning of their careers in our field.

Application Procedure

Graduate student presenters at the meeting in Aix, 14-17 June 2017, should submit an electronic copy of their paper to the editor of *French Colonial History*, Dr. Micheline Lessard mlessard@uOttawa.ca immediately following the meeting. Session chairs are urged to encourage graduate student members of their panels to submit their papers.

William Shorrock Travel Award 2017

The William Shorrock Travel Award is presented annually to help defray travel costs for graduate students presenting papers at the French Colonial Historical Society's annual meeting. In addition to being a long time member and past President of the society, Bill Shorrock was a passionate supporter of graduate students. This award honors his memory and

continues his work as a mentor by providing travel assistance to those just beginning their careers in the field of French colonial history.

Application Procedures

When submitting their completed paper or panel proposals for the annual meeting, graduate students wishing to be considered for the Shorrock Travel Award must also furnish the program committee with an estimated budget of travel expenses (including other anticipated sources of funding) and a brief statement formally applying for the award. Please note that all participants in the annual meeting must be members in good standing of the Society.

Graduate students in French colonial history and related fields, especially students from underrepresented groups, including minorities and first-generation university students, are warmly invited to enroll in these workshops. Faculty mentoring students in these areas are urged to share this announcement with their students and encourage them to participate.

Workshop participants must register for the conference at graduate student rates; there will be no additional charge for participation in the workshops. Some meals may be provided for workshop registrants. The FCHS is working to arrange inexpensive accommodations in local student residences for students attending the conference, including workshop participants.

En parallèle avec son congrès annuel de 2017, la French Colonial Historical Society propose une série d'ateliers destinés aux doctorants en histoire de l'empire et des colonies français et dans des domaines connexes. Ces ateliers visent au développement et au perfectionnement des stratégies de recherche en archives, de publication scientifique, de préparation de candidatures pour des bourses et de création de réseaux professionnels avec des spécialistes et avec des confrères et consoeurs doctorants. Les participants auront la possibilité de rencontrer des chercheurs et archivistes et d'échanger avec eux, ainsi qu'avec des directeurs et des membres de comité scientifique des revues d'histoire coloniale. Call for Papers

The 43rd annual meeting of the French Colonial Historical Society (FCHS) will take place in Aix-en-Provence, France, from 15 to 17 June 2017. The event will be hosted by the Archives nationales d'outre-mer.

This year's theme will be « Actors of French Colonialism, Famous and Unknown», which invites participants to focus on individuals but also on groups or peoples that played a role in the development of colonial empire. However, as usual, proposals on all aspects of overseas France will be considered.

The Society encourages students, scholars, and educators from all disciplines to submit proposals.

Individual paper proposals should include a 100-200 word summary with the title of the paper, name, institutional affiliation, e-mail address, and phone number, and a brief curriculum vitae, all integrated into a single file, preferably in MS-Word.

Proposals for complete panels or round tables will contain the same information for each participant, as well as contact information and a short C.V. for the moderator if one is suggested. The program committee can help find moderators, if necessary.

Please indicate in your proposal whether audiovisual equipment is required.

Individuals wishing to moderate a session should send a statement of interest, contact information, and a brief c.v. as well.

Since the conference is being hosted in France, the organizers ask the participants to present in French whenever possible.

Proposals should be submitted via email to frenchcolonial2017@gmail.com by October 15, 2016.

The FCHS depends on membership dues. All conference participants must be or become members at the time of acceptance (January 2017). Unfortunately, the FCHS does not have funds to subsidize scholars' participation at the meeting. Graduate students, however, may apply for the Shorrock Travel Award; details are provided on the FCHS website (the application must be sent with the proposal).

Appel à Communications

Le 43e congrès annuel de la Société d'Histoire coloniale française (SHCF) se tiendra du 15 au 17 juin 2017 à Aix-en-Provence. Cette manifestation sera accueillie par les Archives nationales d'outre-mer.

Le thème de cette année portera sur les « Acteurs illustres et méconnus de la colonisation française », ce qui permettra de cibler, outre des individualités, des groupes ou des peuples qui ont participé au développement des empires coloniaux. Cependant comme tous les ans, les propositions de communication sur d'autres aspects de l'histoire coloniale française seront prises en considération.

La Société encourage les enseignants, chercheurs et étudiants de toutes disciplines à soumettre des propositions de communication.

Les propositions individuelles doivent indiquer titre de la communication, nom, institution de rattachement, coordonnées (e-mail, téléphone) et comprendre un résumé de 100 à 200 mots et un bref curriculum vitae, en un seul document, de préférence en MS-Word.

Les propositions de sessions complètes ou de tables-rondes doivent contenir ces éléments pour chacun des participants, de même que pour le président/modérateur (le comité scientifique peut aussi aider dans la recherche d'un président/modérateur).
